RETREAT CONTENT:

This Central Regional retreat will be the culmination of the 'Bridging Project: Between Life and Death from Soul to Soul'. You are warmly invited to join others from the region and the local community in a gathering to artistically experience, in time and space, the journey of the soul through the cycle of life and after-death, as indicated from the spiritual research of Rudolf Steiner. We will each have a chance to walk the pathway of our beloved across the threshold, being present for them, as well as preparing for our own journey.
